Торіс	Recommendation of Joseph Patterson for nomination to the Supervisory Board

1. The Supervisory Board Nomination Process

As of August 2019, the Supervisory Board (the "SB") adopted the Dutch Structure Regime requiring that members of the SB be appointed by the General Meeting upon nomination by the SB. In SB Nomination Procedures adopted following the 2019 General Meeting, the SB People Committee (the "SBPC") was tasked with coordinating and carrying out SB nomination procedures and submitting its report and recommendations to the SB.

At the June 2020 General Meeting, Ms. Annette Austin and Ms. Asa Silfverberg will complete their second terms and will leave the SB. In accordance with the recommendation of the SB and the vote of Members at the 2019 General Meeting, their departure will result in the reduction of the size of the SB from 11 to 9 members. Mr. Joseph Patterson will complete his first term, resulting in one vacancy on the SB.

In a Vacancy Announcement dated November 29, 2019, the SBPC announced the single vacancy on the Oikocredit SB and invited Oikocredit Members, the Members council, the Managing Board and the Works Council to recommend candidates for the 2020 nomination of one member to the SB. Incumbent SB member Joseph Patterson expressed his interest in serving a second term on the SB and was recommended by the United Church of Canada and Oikocredit Canada. No other candidates were recommended by stakeholders and no other persons applied for SB membership.

Detailed information regarding Mr. Patterson's professional career is included in the attached CV. The CV includes the following information required by Article 28.6 of the Articles of Association of Oikocredit: his age, profession, the positions he has held in the past that are relevant to his duties on the SB, and the names of the legal entities for which he currently acts as a member of the supervisory board or board of commissioners.

In November 2019, Mr. Patterson's SB colleagues were asked to evaluate his performance as an SB member. SB members noted Mr. Patterson's commitment to Oikocredit, his inclusive approach to SB meetings and good communication skills, his sound knowledge of financial and business matters, and his development of a strong and collaborative working relationship with the Managing Board, including the Managing Director.

In January, 2020, Oikocredit's Compliance Officer conducted a compliance screening which revealed no risk in relation to Mr. Patterson's candidacy. In addition, General Counsel Jetske van Breugel provided a conflict of interest analysis in which she concluded that any potential conflicts could be managed by Oikocredit's Conflict of Interest Policy.

Two members of the SBPC interviewed Mr. Patterson on February 12 and confirmed that he meets the criteria mentioned in the Articles of Association as well as the general, specific and personal profile competencies mentioned in the Vacancy Announcement. Those competencies include senior management experience, strategic experience in a business discipline, audit and risk experience, indepth financial analysis experience, leadership experience, and dedication to social and economic development. In addition, the SBPC noted Mr. Patterson's strong belief in Oikocredit, his belief in the

opportunity for Oikocredit to remain relevant in a world that is changing rapidly through technology and digitalization, and his awareness of the challenges the organization faces in an increasingly difficult market.

On February 7, the Managing Board and Works Council were notified of Mr. Patterson's eligibility for nomination to the SB. The SBPC invited the Managing Board and Works Council to raise any concerns they might have in relation to Joseph's candidacy and to share any information they might feel relevant to his candidacy. No information was shared by the Managing Board or Works Council.

On February 7, the SBPC also notified Ueli Burkhalter and Hans van Nie, the two Member representatives appointed by the Members Council, of Mr. Patterson's candidacy. The Member representatives received all of Mr. Patterson's application documents as well as a report on the outcomes of compliance screenings. On February 18, Mr. Burkhalter and Mr. van Nie participated in a BlueJeans conference call with SBPC members in which they were given the opportunity to offer their advice and recommendations regarding both Mr. Patterson's candidacy and the SB nomination procedures. Both Member representatives expressed appreciation for Joseph's communications skills and his support for the Members' Council and recommended appointment of Mr. Patterson to the SB.

2. Recommendation and Nomination

In light of the favorable evaluation of Mr. Patterson's colleagues on the SB, the results of Mr. Patterson's screenings and SBPC interviews, and the positive feedback provided by Members representatives, the SBPC recommended the nomination of Joseph Patterson to the SB. At its meeting on March 4, 2020, the full SB unanimously accepted the recommendation and voted to nominate Mr. Patterson for appointment to the SB.

3. Appointment

At the General Meeting in June, Members will be asked if they have any objection to the nominated candidate in a vote and, in the case of an objection, will be required to state the grounds for the objection. Only the following grounds specified in Article 28.8 of the Articles of Association may form the basis for an objection:

- The procedures established by Articles 28.4, 28.5 and 28.6 for appointment to the SB have not been followed (including notification of a vacancy on the SB, notification of the name of the person nominated, notification of information regarding the candidate and the reasons for nomination),
- The expectation that the nominee is unable to fulfill his duties as member of the SB, or
- The expectation that the SB will not be properly composed if the nominee is appointed.

If no objection is made by the General Meeting or the Works Council, or if a vote is held but there is no majority in favor of the objection, Mr. Patterson will be appointed to the SB.

4. Next steps

If Mr. Patterson is appointed to the SB, the SB will be composed of 9 members with the following terms:

The SB Governance Committee is currently considering procedures for staggering the terms of those elected in 2019 to ensure stability and continuity on the SB as well as smooth appointment processes. The procedures considered will be presented at the General Meeting in June.
